

**Barnes® Bullets Ammo Twitter® Sweepstakes
Official Rules**

1. SWEEPSTAKES PERIOD; ENTRY. This Barnes Bullets Ammo Twitter Sweepstakes (this "Sweepstakes") starts on October 1, 2015 at 12:00:01 AM Eastern Daylight Time ("EDT") and ends at or about October 14, 2015 at 12:00:01 AM Eastern Daylight Time and once Sponsor verifies winner ("Sweepstakes Period"). To enter, visit <https://twitter.com/barnesbullets> and follow @BarnesBullets on Twitter (if you do not already do so) during the Sweepstakes Period and, if you meet the eligibility criteria below, you will automatically be entered into the Sweepstakes. 2. ELIGIBILITY. Sweepstakes is open to all legal residents of the 50 United States and Washington, D.C., who are 21 years of age or older at the time of entry, and registered Twitter account holders in good standing who follow @BarnesBullets. Joining Twitter is free. See www.twitter.com for details. Employees of Sponsor and its affiliates, subsidiaries, parent company, suppliers, distributors, advertising, promotion or any other agents, entities, and representatives involved with this Sweepstakes ("Sweepstakes Entities") and members of such employee's families (parents, siblings, children, and their respective spouses) and/or those residing in the same household as such employees (whether related or not) are not eligible to participate in this Sweepstakes. Potential winner may be required to provide proof to Sponsor that he or she is the authorized account holder of the Twitter account following @BarnesBullets on Twitter.

3. DRAWINGS; ODDS; PRIZE AWARDING. Sponsor will randomly select 1 winner from among all eligible entrants during Sweepstakes Period. Odds of winning depend on the number of eligible entrants during Sweepstakes Period. Potential winners will be notified by Sponsor by Tweet and/or direct message and be asked to provide his or her age, full name, residence address, email and/or daytime phone number (no post office boxes accepted). In order to receive a direct message from Sponsor, you must (A) be following @BarnesBullets on Twitter and (B) have your account settings set to "unprotected" and/or "public" mode. If (i) the @BarnesBullets account is blocked from contacting the potential winner via direct message, or the potential winner does not respond to initial notification within 2 days of the date of notification, (ii) the potential winner is found to be ineligible, (iii) the potential winner cannot or does not comply with these Official Rules, or (iv) the Winner Documents described below is returned as undeliverable or not received by due date, the potential winner will be disqualified and forfeit the prize and Sponsor will select an alternate potential winner from remaining eligible entrants. Sponsor will coordinate with potential winner regarding Sweepstakes via email, phone, or mail, in Sponsor's discretion. Prize is winner's choice of 5 boxes (20 rounds per box) of Barnes® RangeAR Ammunition 5.56x45mm NATO 52 Grain (Open-Tip Match)(Approximate Retail Value ("ARV"): \$95, plus up to \$15 shipping, if applicable) **OR** 5 boxes (20 rounds per box) of Barnes® RangeAR Ammunition 300 AAC Blackout 90 Grain (Open-Tip Match)(Approximate Retail Value ("ARV"): \$107.50, plus up to \$15 shipping, if applicable). **Prize does not include any firearm for use with ammunition.
